- b. Minimum rates as set out in Article 7 are basic minimum scales and nothing in this Agreement shall prevent the Employer from paying the Employees a rate higher than these minimum rates, but the Employer will not be obligated to pay more than the minimum rates without bargaining with an individual Employee for a higher rate and reaching an agreement to pay that Employee a higher rate.
- c. **Statutory Holiday Pay:** Employees will be entitled to Statutory Holiday Pay based on the applicable provincial employment standards.
- d. 12-hour daily rates are based on twelve (12) guaranteed hours per week which is equivalent to fourteen (14) "pay hours".
